Team: \$4 per team Team entry must be made prior to the commencement of match.
A team will consist of 4 firing members of club/school.
- Categories:** Junior – Born in 1991, 1992, 1993 Intermediate Junior – Born in 1994, 1995, 1996
Sub-Juniors – Born in 1997 or later
- Classification:** All competitors will be classified in accordance with NRA Rule 2.3, 2.3.1 & 2.3.2 of the NRA Smallbore Rifle Rule Book. Team classification will be in accordance with NRA definition.
- Arms & sights:** NRA rules will govern the tournament where not indicated below.
A) Metallic Sights (NRA Rule 3.7a) B) Unlimited sighters allowed during shooting period
C) Competitors provide own target clips D) ***Eye & ear protection required.***
- Challenge:** \$1.00 per challenge. Time limit for challenge is one (1) hour after score is posted.
