DSC Election Voting Procedures 2011

Candidates

The election slate of candidates is presented to the membership at the Nov. general membership meeting. Candidates that wish to address the membership will be allotted three minutes to do so. Candidates, submitted resumes and pictures will be posted on the DSC website and printed in the P & K.

Election

The election starts Monday Nov. 14, 2011. All voting is at the DSC Office. Members can vote during normal office hours. Additionally the DSC Office will be open Saturday December 3, 2011 from 10am to 2pm. Polls close at General Membership meeting on Dec. 7, 2011 at 8 p.m. You must be in the office to cast your vote prior to 8 p.m.. If a member would like, they may vote by absentee ballot. A sample ballot, with the slate of candidates, will be printed in the November and December P & K and posted on the DSC website.

Voting

All voting is by ballot. You get one vote for each of the officers and trustee and you get six votes for directors. If you exceed these vote totals in any one office, you will void your entire ballot. This includes in person and absentee voting.

Absentee Ballot Procedures

A member may request absentee ballot from the DSC Office. Absentee ballots will not be mailed prior to Nov. 14 2011. The Detroit Sportsmen's Congress takes no responsibility for any unforeseen delays by the U.S. Postal Service. Write your membership number in the upper right hand corner of the ballot.

Complete your selections on the ballot. Place ballot in a sealed envelope labeled "ABSENTEE BALLOT".

Place the sealed envelope, *into another envelope* addressed to the DSC office at 49800 Dequindre, Utica, MI 48317, marked Attn: Election Committee. Additionally, in this envelope, you MUST include your membership card. If your membership card is not included, the sealed envelope with the absentee ballot inside will be destroyed. If you desire your membership card returned, also include a self-addressed stamped envelope. Otherwise, the DSC Office will retain your card for you to pick up.

Sealed envelopes with the absentee ballots inside will then be placed into the election box with all other ballots. Envelopes will not be opened until Election Committee tallies the vote. Only those ballots in sealed envelopes will be opened and counted.

All absentee ballots must be received at the DSC Office before the polls close at 8 p.m. Dec. 7 2011. It is the member's responsibility to respond in a timely manner. The Election Committee cannot be responsible for any delays by the U.S. Postal Service.

Failure to follow absentee ballot procedures correctly will void your ballot.
